# Environmental Assessment Principles and Methods / Environmental Protection and Impact Assessment

In Fall 2019, RRMT238, *Environmental Protection and Impact Assessment* is being offered at Yukon College concurrent with the University of Alberta's RENR307, *Environmental Assessment Principles and Methods*, as part of the Northern Environmental and Conservation Sciences, B.Sc. Program. All students registered in RRMT238 or RENR307 must adhere to requirements outlined in this course syllabus. #### **COURSE DESCRIPTION:**

Environmental and socio-economic effects assessment ensures that the effects of development activities are considered before they happen and that significant adverse effects will be mitigated.

This course is comprised of the following assessment topics:

- Environmental assessment in Yukon, YESAB & YESAA
- Impact assessment methodology, VESEC selection and significance determination
- Socio Economic Effects Assessment
- Assessment of impacts to 'Water'
- Assessment of impacts to 'Aquatic Systems'
- Assessment of impacts to 'Soils and Vegetation'
- Assessment of impacts to 'Wildlife and Habitat'

- Cumulative Effects Assessment
- Assessment of remediation projects
- Adaptive Management

During the course, the students will look through a number of case studies to understand how environmental and socio-economic impact assessments are conducted. Multiple guest speakers will be coming to the classroom and the students will engage with our guests in discussions related to environmental assessment in Yukon and the implementation of YESAA. Finally, the students will have to present one assessment and its conclusion for a project of their choice.

#### STUDENT LEARNING OUTCOMES AND COMPETENCIES:

Upon successful completion of this course students will be able to do the following:

- Understand the history and reasons for conducting assessments
- Understand assessment timelines and process.
- Understand who participate in assessments, why and in which capacity
- Be aware of opportunities for public participation and public engagement in the process.
- Understand what information is required and incorporating information into assessments
- Understand how assessments are conducted using the available information and how the final impact significance determination are made

#### **COURSE FORMAT:**

The course consists of one 3-hour lecture per week.

## **COURSE PREREQUISITES AND/OR CO-REQUISITES:**

For students taking the course as RRMT 238: Admission to the second year of the Yukon College Renewable Resources Management Program.

For students taking the course as RENR 307: Registration in Yukon College/University of Alberta B.Sc. in Environmental and Conservation Sciences degree program.

## **Plagiarism**

Plagiarism is a serious academic offence. Plagiarism occurs when a student submits work for credit that includes the words, ideas, or data of others, without citing the source from which the material is taken. Plagiarism can be the deliberate use of a whole piece of work, but more frequently it occurs when students fail to acknowledge and document sources from which they have taken material according to an accepted manuscript style (e.g., APA, CSE, MLA, etc.). Students may use sources which are public domain or licensed under Creative Commons; however, academic documentation standards must still be followed. Except with explicit permission of the instructor, resubmitting work which has previously received credit is also considered plagiarism. Students who plagiarize material for assignments will receive a mark of zero (F) on the assignment and may fail the course. Plagiarism may also result in dismissal from a program of study or the College.

#### PROFESSIONALISM AND CLASSROOM RULES OF ENGAGEMENT

Students are expected to attend all lectures and labs, be engaged and courteous in all course activities, and to be on time for class. Please do not use cellular phones during class. Laptops are permitted for note taking and in-class work; however, please do not use laptops in class for non-class-related activities. ## COURSE REQUIREMENTS/EVALUATION:

Participation in class

Attendance is mandatory. Unexcused absences from more than 10% of activities may result in a failing grade.

Questions to invited speakers

Students will be asked to prepare questions in advance of the lectures by guest speakers. After the guest speaker presentation, the students will ask their question to the invited speakers. The purpose of this exercise is to encourage discussion and dialogue with practitioners. The questions should be submitted on Moodle prior to the lecture. Submission of all questions will count as 10% of the final grade.

# Assignment #1 and #2

Instructions for Assignment #1 and #2 will be made available on Moodle during the term and will be discussed in class with the instructor. Students will be required to submit their assignment on Moodle on or before the deadline. There will be two assignment, Assignment #1 (15% of final grade) and Assignment #2 (15% of final grade).

## Presentation

Students will be required to study and present to the class the significance determination made on a project submitted to YESAB. The instructions, requirement and format required for the presentation will be presented by the instructor. Students will have to choose one project to study from the YESAB Online Registry. The purpose of this exercise is to compare significance determination from numerous case studies and to learn from each other in class. The students won't be marked on their presentation skills but rather will be marked on their understanding of the determination of significance made on the project they present.

# Exams

There will be one midterm exam and a take-home exam. The midterm will be scheduled during class time TBA and will count for 15% of the final grade Student will be asked to review and mark their own exam on the class following the exam.

The take-home exam will be distributed on Moodle and students will have one week to submit their work. This take-home exam will count as 20% of the final mark.
