## REPORT FROM FARC

Chris Milner provided an update on the FARC meeting held February 1<sup>st</sup>, 2018.

#### Review preliminary budget for 2018-2019

The draft budget for 2018-19 was reviewed by FARC and provided to the Board in the meeting package for review.

#### University Transition Budget Update

The revised university transition budget for 2018-19 was reviewed by FARC and provided to the Board in the meeting packge for review.

#### 2017 Management Board Submission Update

At the request of Yukon Government, the College is not putting forward any capital funding requests for the current year.

This request reflects both the current fiscal realities of the Yukon Government and the ongoing request for university funding.

#### Management Response to Management Letter from 2016-2017

The management letter was reviewed by management and a response was sent to the auditors, and was provided to FARC for information.

## IT Security Audit Update

Karen Barnes explained that an initial IT vulnerability audit has been completed. The results of the audit were provided in the meeting package for FARC to review.

All recommended action points from this audit have been addressed and completed.

Katie Tuck (IT Manager) will be attending the April FARC meeting to provide further information with regards to the approach to be taken to mitigate risk moving forward for the College

#### Risk Management

The College has been working with the Yukon Government on developing a university transition budget. While discussions continue on a longer term budget, a budget for 18-19 was submitted at the request of the Minister.

The revised funding levels being sought for 18-19 will be sufficient to stay on track with advancement of specific degrees.

## Policy Grievance update

Michael Hale clarified that the policy grievance around Supplemental Benefits has been resolved. Only legal costs will be required.

## REPORT FROM GOVERNANCE COMMITTEE

Vera Holmes provided an update on the Governance meeting held January 11<sup>th</sup> & February 2nd.

#### **Board Competency Matrix Review**

The updated Board Competency Matrix was provided in the Governance and Board meeting package for review.

#### Dicussion items included:

- Gaps in the current matrix should be identified for all the upcoming vacancies
- Current First Nation Rep vacancy was advertised through CYFN in December but there were no nominations made. CYFN has just sent out another advertisement in January.
- Upcoming Member at large vacancy has been communicated to Yukon Government and an advertisement has just gone out in January.
- Upcoming Community Campus Rep vacancy notification letter has been mailed to the Community Campus Chairs asking them to advertise the vacancy to their Committee members for the opportunity to apply
- Will be adventagious to have someone who can fill the gap in the legal feild in the matrix

#### Revised BOG-17 Board Member Selection Process

A revised version of Policy BOG-17 Board Member Selection Process was brought forward for the Governance Committee to review. The official appointment process that was agreed upon with the Minister of Education was also provided.

Recommended changes to the Policy included:

- Removing the detailed appointment process in the policy and inserting an overall statement that the process will be reviewed annually and agreed upon by Government.
- Add the official appointment process as a reference document at the end of the Policy after the Board matrix

No objections to the recommended changes were made by the Board

MOVED by Vera Holmes, SECONDED by Carol Geddes that the Board of Governors approve the recommended changes to Policy BOG-17 Board Member Selection Process as presented. CARRIED

#### Results of Interim Evaluation

Yukon College Board of Governors have completed an interim evaluation questionnaire that assesses their own contribution as well as the Board as a whole. The Governance Committee reviewed the evaluation results and identified recommendations it wanted to raise with the Board.

The Board agreed there is value in the feedback and to continue doing both the interim and year end evaluations.

#### **Broad Board & Senate Powers**

The final Board and Senate powers that were agreed upon at the Governance meeting on Januray 11<sup>th</sup> were brought forward to the Board for approval. The final documents were provided in the meeting package for review.
