1. Purpose of Policy

The designation "emeritus" or "emerita" recognizes the outstanding contributions of retired presidents to the University and to the community, including demonstrated excellence, outstanding service, and effective leadership beyond normal expectations.

2. Governing Legislation and Relevant Documents

Yukon University Act

3. Scope

The policy applies to retired Yukon University presidents and to those who have announced their retirement.

4. Definitions

Emeritus/Emerita: an honorary title, which may be granted to retired faculty
members, administrators, and presidents who have given distinguished service to the
institution.

5. Guiding Principles

The following guiding principles apply to this policy:

- The granting of emeritus or emerita status provides intangible benefits to both the institution and to the recipient; and
- Presidents Emeriti are not required to continue to serve the University or the community but may do so at their own discretion.
