# **Tuition Refund Policy** – SS 9.0

Office of the Registrar

## 1. Purpose of Policy

If the University cancels a course or program, fees will be refunded in full. Otherwise, students must follow the Yukon University withdrawal procedure in order to be eligible for a refund. The date of official withdrawal is the date used for refund calculation, not the date on which the student discontinues attending classes.

- Refunds are not immediate. Refund cheques are mailed within a week to 10 days following official withdrawal.
- Refunds are normally issued directly to the student. In case of a third party authorized invoicing by purchase order or sponsor letter, the sponsor will be refunded.
- Any debts owed to the University will be deducted from the amount to be refunded.
- Exceptions to this policy may be made for compassionate reasons, by application to the registrar.

### 2. Governing Legislation and Relevant Documents

Yukon University Administrative Policies will not conflict with Board Policies. Administrative policies provide the parameters within which the Board Policies are to be implemented.
